

# KUSH ARORA CRIMINAL JUSTICE REFORM SCHOLARSHIP APPLICATION

This scholarship will award \$500 to a deserving student who has demonstrated a thoughtful, well-reasoned view of whether certain laws and criminal justice policies are just or unjust.

## Eligibility and Selection Criteria:

- The scholarship program is available to undergraduate, graduate, and law school students as well as incoming college freshmen.
- The candidate must be in good academic standing with at least a 3.0 minimum cumulative GPA.

## Application Requirements:

The Kush Arora Criminal Justice Scholarship program invites all candidates who meet the aforementioned criteria to apply. Applicants will be evaluated based on the following:

- Applicants must submit a complete application, including this Cover Sheet, and both the essay and academic transcript described below.
- Applicants must submit a 1,000-word essay responding to one of the following prompts (they will be judged on the best-reasoned response, not on the position of the applicant):
  - Provide a well-reasoned argument about whether a specific policy in the criminal justice system (your choice) is unjust and requires reform, or is just and should stay the same.
  - Provide a well-reasoned argument defending or critiquing the criminalization of drug possession in the United States.
